A RESOLUTION AUTHORIZING THE ISSUANCE OF A SPECIAL USE PERMIT TO UNIOIL PETROLEUM PHILIPPINES, INC., FOR THE OPERATION OF AN AUTO LIQUEFIED PETROLEUM GAS (LPG) REFILLING STATION LOCATED AT NO. 33 QUEZON AVENUE, BARANGAY LOURDES, QUEZON CITY.

WHEREAS, petitioner Unioil Petroleum Philippines, Inc. a duly registered juridical entity has applied for the issuance of a Special Use Permit (SUP) for the operation of an Auto Liquefied Petroleum Gas (LPG) refilling station;

WHEREAS, filling stations are among the uses which require a Special Use Permit upon authorization from the Quezon City Council as provided in Ordinance No. SP-918, S-2000, otherwise known as the Quezon City Comprehensive Zoning Ordinance of 2000;

WHEREAS, the Unioil Petroleum Philippines, Inc., has complied with the requirements for the issuance of a Special Use Permit as required by said ordinance;





WHEREAS, the operation of an Auto Liquefied Petroleum Gas (LPG) refilling station will promote public welfare and economic development, through the projected increase of employment opportunities in our City.
