
A RESOLUTION STRONGLY URGING ALL BARANGAYS IN QUEZON CITY TO STRICTLY IMPLEMENT REPUBLIC ACT NO. 9262, OTHERWISE KNOWN AS THE "ANTI-VIOLENCE AGAINST WOMEN AND THEIR CHILDREN ACT OF 2004."

WHEREAS, it is a declared policy of the state to value women and children and guarantee full respect for human rights and that it also recognizes the need to protect the family and its members particularly women and children from violence and threats to their personal safety and security;

WHEREAS, on March 8, President Gloria Macapagal-Arroyo signed the Anti-Violence Against Women and their Children Act (Republic Act No. 9262) which penalizes men who abuse their female partners or their children with up to sixteen (16) years in jail and will be penalized by a fine of P100,000.00 to P300,000.00 and will undergo psychological counseling or psychiatric treatment;

WHEREAS, the said law not only increases the prison term for violators from six (6) to sixteen (16) years but also include the payment of compensatory moral and exemplary damages to the victims;

WHEREAS, it is imperative to absolutely implement the said law in the barangay level in order to closely monitor and prevent any violation of the same;

WHEREAS, to carry out the aforementioned objectives, it is necessary to strictly implement Republic Act No. 9262 so as to ensure the safety of our women and children from any forms of violence and harassments.

## NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to urge, as it does hereby urge all barangays in Quezon City to strictly implement Republic Act No. 9262, otherwise known as the "Anti-Violence Against Women and their Children Act of 2004."
