A RESOLUTION DECLARING MARCH 10 OF EVERY YEAR AS "ARAW NG MGA BUNTIS" AND CREATING A SPECIAL COMMITTEE TASKED WITH PROVIDING FOR AND IMPLEMENTING A PROGRAM OF ACTIVITIES FOR THE SAID OCCASION.

WHEREAS, the Department of Health together with the Philippine Obstetrical and Gynecological Society – Capitol City wide had been conducting a yearly program which addresses the concerns and issues of women's reproductive health, in consonance with the efforts of the local government in ensuring and providing efficient delivery of quality medical services to pregnant women;

WHEREAS, Ligtas Buntis Campaign is a nationwide health program of our government on Family Planning and safe motherhood which intends to reduce maternal, neonatal and infant mortality;


WHEREAS, likewise the said health program aims to increase the visibility of family planning as an essential public health service to the community and to improve the access of couples, women and men to family planning and safe motherhood.

NOW, THEREFORE,


BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to declare, as it does hereby declare March 10 of every year as "Araw ng mga Buntis".

RESOLVED, FURTHER, to create, as it does hereby create a special committee to formulate the program of activities and implement the same.


