RESOLUTION NO. SP-**4350**S-2008

A RESOLUTION GRANTING FINANCIAL ASSISTANCE TO THE BEREAVED FAMILY OF THE LATE BARANGAY TREASURER AND FORMER BARANGAY KAGAWAD FLORENTINO REYES, OF BARANGAY APOLONIO SAMSON, QUEZON CITY, WHO DIED ON OCTOBER 3, 2008, IN THE AMOUNT OF FIFTY FIVE THOUSAND PESOS (P55,000.00) TO BE CHARGED AGAINST THE APPROPRIATION FOR GRANTS, SUBSIDIES AND CONTRIBUTIONS OF THE 2008 ANNUAL BUDGET OF THE OFFICE OF THE CITY MAYOR OR FROM ANY AVAILABLE FUNDS OF THE CITY TREASURY.



WHEREAS, Barangay Treasurer and former Barangay Kagawad Florentino Reyes had served Barangay Apolonio Samson since 1982 - 1984 and from 1994 up to the time of his death as Barangay Treasurer and from 1989 up to 1994 as Barangay Kagawad;

WHEREAS, in his twenty-six (26) years of public service Barangay Treasurer and former Barangay Kagawad Reyes was not involved in any irregularities, but instead admired by the Barangay officials he worked with and the constituents he served for his dedication, commitment, loyalty, integrity and honesty;

WHEREAS, as Barangay Treasurer and former Barangay Kagawad, he was efficient in the collection of taxes and charges which redounded to the benefit of the Barangay constituents in terms of projects and services;


WHEREAS, in recognition of his exemplary services and as a gesture of sympathy to his surviving heirs, it is appropriate to extend financial assistance to his immediate family.

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to grant, as it does hereby grant financial assistance to the bereaved family of the late Barangay Treasurer and former Barangay Kagawad Florentino Reyes, of Barangay Apolonio Samson, Quezon City, who died on October 3, 2008, in the amount of Fifty Five Thousand Pesos (P55,000.00), chargeable against the appropriation for grants, subsidies and contributions under the 2008 Annual Budget of the Office of the City Mayor or from any available funds of the City Treasurer.
