A RESOLUTION GRANTING FINANCIAL ASSISTANCE IN THE AMOUNT OF FIFTY FIVE THOUSAND PESOS (P55,000.00) TO THE BEREAVED RAMILY OF THE LATE TEODORO C. DIAZ, INCUMBENT BARANGAY KAGAWAL), BARANGAY CULIAT, QUEZON CITY, WHO DIED ON OCTOBER 28, 2008, CHARGEABLE AGAINST THE APPROPRIATIONS FOR GRANTS, SUBSIDIES AND CONTRIBUTIONS UNDER THE 2008 ANNUAL BUDGET OF THE OFFICE OF THE CITY MAYOR OR FROM ANY AVAILABLE FUNDS OF THE CITY TREASURY.

WHEREAS, the late Kagawad Diaz of Barangay Culiat, Quezon City, had served his barangay constituents from March 28, 1989 to May 31, 1997 and from November 30, 2007 up to the time of his death;

WHEREAS, on October 28, 2008, Kagawad Diaz died due to heart ailment, to the grief of his family who were left to fend for themselves;

WHEREAS, in recognition of his dedicated, unselfish and loyal public service to his constituents, it is fitting to extend financial assistance to his bereaved family or surviving heirs.
