RESOLUTION NO. SP-4382, S. 2008

A RESOLUTION GRANTING FINANCIAL ASSISTANCE TO THE SIXTEEN (16) FAMILIES RESIDING AT KASIPAGAN STREET, GULOD, KALAYAAN B, BARANGAY BATASAN HILLS, QUEZON CITY, WHOSE HOUSES WERE GUTTED BY A FIRE THAT OCCURRED ON OCTOBER 29, 2008, IN THE AMOUNT OF THREE THOUSAND PESOS (P3,000.00) PER HOUSE OWNER AND TWO THOUSAND PESOS (P2,000.00) PER HOUSE RENTER/SHARER, TO BE CHARGED AGAINST THE APPROPRIATION FOR GRANTS, SUBSIDIES AND CONTRIBUTIONS UNDER THE 2008 ANNUAL BUDGET OF THE OFFICE OF THE CITY MAYOR OR FROM ANY AVAILABLE FUNDS OF THE CITY TREASURY.

WHEREAS, on October 28, 2008, a destructive fire occurred at Kasipagan Street, Gulod, Kalayaan B, Barangay Batasan Hills, Quezon City, leaving sixteen (16) families therein homeless;

WHEREAS, to alleviate the plight of the fire victims and to enable them to start anew, an appropriate financial assistance must be extended to them by the City government.

NOW, THEREFORE,


BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to grant, as it does hereby grant financial assistance to the Sixteen (16) families residing at Kasipagan Street, Gulod, Kalayaan B, Barangay Batasan Hills, Quezon City, whose houses were gutted by a fire that occurred on October 29, 2008, in the amount of Three Thousand Pesos (P3,000.00) per house owner and Two Thousand Pesos (P2,000.00) per house renter/sharer, to be charged against the appropriation for Grants, Subsidies and Contributions under the 2008 Annual Budget of the Office of the City Mayor or from any available funds of the City Treasury.

RESOLVED, FURTHER, that a copy of this resolution be forwarded to the Office of the City Mayor and the Social Services and Development Department (SSDD) for their information and appropriate action.


