RESOLUTION NO. SP. 4386 S-2008

A RESOLUTION GRANTING FINANCIAL ASSISTANCE IN THE AMOUNT OF FORTY THOUSAND PESOS (P40,000.00) TO THE BEREAVED FAMILY OF THE LATE REYNATO G. RAMOS, FORMER PUNONG BARANGAY AND BARANGAY KAGAWAD OF BARANGAY TANDANG SORA, QUEZON CITY, WHO DIED ON OCTOBER 24, 2008, CHARGEABLE AGAINST THE APPROPRIATION FOR GRANTS, SUBSIDIES AND CONTRIBUTIONS UNDER THE 2008 ANNUAL BUDGET OF THE OFFICE OF THE CITY MAYOR OR FROM ANY AVAILABLE FUNDS OF THE CITY TREASURY.

Introduced by Councilors EDEN "Candy" A. MEDINA, ANTONIO E. INTON, JR., WINSTON "Winnie" T. CASTELO, RAMON P. MEDALLA, ALLAN BUTCH T. FRANCISCO, VOLTAIRE GODOFREDO L. LIBAN III and AIKO S. MELENDEZ.

WHEREAS, the late Punong Barangay Ramos started his dedicated public service as elected Barangay Kagawad in February 1982 to 1984 and after the popular Edsa Revolution he was appointed Barangay Captain on December 12, 1988 which lasted in 1989;

WHEREAS, on March 28, 1989 he was re-elected as Barangay Kagawad and finished the corresponding term in 1994. Thereafter, he did not seek for re-election in any public office;

WHEREAS, on October 24, 2008, Punong Barangay Ramos died due to cardiogenic shock making his family to suffer emotionally and financially;

Ramos, former Punong Rarangay and Barangay Kagawad of Barangay Tandang Sora, Quezon City in the amount of Forty Thousand Pesos (P40,000.00) who died on October 24, 2008, chargeable against the appropriation for Grants, Subsidies and Contributions under the 2008 Annual Budget of the Office of the City Mayor or from any available funds of the City Treasury.
