RESOLUTION NO. SP-4393S-2008

A RESOLUTION AUTHORIZING THE SANGGUNIANG BARANGAY OF BARANGAY STA. LUCIA, QUEZON CITY, TO HOLD A SPECIAL COCKFIGHT OR PINTAKASI ON DECEMBER 12, 13 AND 14, 2008 FOR THE SUPPORT OF FUND RAISING CAMPAIGN FOR CHARITABLE PURPOSES.

WHEREAS, Barangay Sta. Lucia will be celebrating its Barangay Fiesta commencing on December 12, 2008;

WHEREAS, to alleviate the plight of Barangay inhabitants during the yuletide season, the Sangguniang Barangay of Barangay Sta. Lucia came up with a gift-giving project for the indigent families dubbed as "Pamaskong Handog";

WHEREAS, to ensure the resounding success of the said charitable project, the Sangguniang Barangay will launch a fund raising drive through special cockfight or pintakasi to be held on certain days during the Barangay Fiesta celebration;

WHEREAS, in support of the said project, the Sangguniang Barangay of Barangay Sta. Lucia passed a Resolution No. 313, S-2008, requesting the City Council to allow them to conduct cockfighting or pintakasi;

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize the Sangguniang Barangay of Barangay Sta. Lucia to hold a "Special Cockfight" or Pintakasi on December 12, 13 and 14, 2008, for the support of fund raising campaign for charitable purposes.

RESOLVED, FURTHER, that a copy of this Resolution be furnished to the Office of the City Mayor and the Quezon City Police District, for their information and appropriate action.
