A RESOLUTION GRANTING FINANCIAL ASSISTANCE IN THE AMOUNT OF FIFTY FIVE THOUSAND PESOS (P55,000.00) TO THE BEREAVED FAMILY OF THE LATE EDUARDO POMAR, FORMER BARANGAY KAGAWAD AND INCUMBENT BARANGAY PEACE SECURITY OFFICER (BPSO) EXECUTIVE OFFICER OF BARANGAY BATASAN HILLS, QUEZON CITY, WHO DIED ON FEBRUARY 3, 2009, CHARGEABLE AGAINST THE APPROPRIATIONS FOR GRANTS, SUBSIDIES AND CONTRIBUTIONS OF THE 2009 ANNUAL BUDGET OF THE OFFICE OF THE CITY MAYOR OR FROM ANY AVAILABLE FUNDS OF THE CITY TREASURY.

WHEREAS, the late former Kagawad Eduardo Pomar of Barangay Batasan Hills, Quezon City, has served his barangay constituents from 1994 to 1997 and thereafter appointed as Barangay Peace Security Officer (BPSO) Executive Officer until his death on February 3, 2009;

WHEREAS, on February 3, 2009, Kagawad Pomar was shot to death by still an unidentified lawless elements while responding to a call of duty;

WHEREAS, in recognition of his dedicated, unselfish and loyal public service to his constituents, it is fitting to extend financial assistance to his bereaved family or surviving heirs.
