RESOLUTION NO. SP **4523** S. 2009

A RESOLUTION GRANTING FINANCIAL ASSISTANCE TO THE BEREAVED FAMILY OF THE LATE ELEUTERIO M. GALGANA, FORMER PUNONG BARANGAY, BARANGAY SANGANDAAN, QUEZON CITY, WHO DIED ON DECEMBER 3, 2005, IN THE AMOUNT OF THIRTY THOUSAND PESOS (P30,000.00), CHARGEABLE AGAINST THE APPROPRIATION FOR GRANTS, SUBSIDIES AND CONTRIBUTIONS UNDER THE 2009 ANNUAL BUDGET OF THE OFFICE OF THE CITY MAYOR OR FROM ANY AVAILABLE FUNDS OF THE CITY TREASURY.

WHEREAS, the late Eleuterio M. Galgana served Barangay Sangandaan as Barangay Kagawad from 1982 to 1990 and as Punong Barangay from 1990 to 1994;

WHEREAS, during his incumbency he performed his duties and responsibilities with utmost dedication, loyalty and fidelity which redounded to the benefit of the barangay inhabitants;

WHEREAS, on December 3, 2005, due to ailment, Punong Barangay Eleuterio M. Galgana passed away to the grief of his family and constituents;


WHEREAS, as a token of gratitude to the humble public service rendered by the late Punong Barangay Galgana, it is appropriate for the City Government to extend financial assistance to his surviving heirs.

Galgana, former Punong Barangay, Barangay Sangandaan, Quezon City, who died on December 3, 2005, in the amount of Thirty Thousand Pesos (P30,000.00) chargeable against the appropriation for grants, subsidies and contributions under the 2009 Annual Budget of the Office of the City Mayor or from any available funds of the City Treasury.
