RESOLUTION NO. **4524** S-2009

A RESOLUTION GRANTING FINANCIAL ASSISTANCE TO THE BEREAVED FAMILY OF THE LATE TEODORO O. CUADRA, FORMER BARANGAY KAGAWAD AND LUPON TAGAPAMAYAPA OF BARANGAY SANGANDAAN, QUEZON CITY, IN THE AMOUNT OF THIRTY THOUSAND PESOS (P30,000.00) CHARGEABLE AGAINST THE APPROPRIATIONS FOR GRANTS, SUBSIDIES AND CONTRIBUTIONS UNDER THE 2009 ANNUAL BUDGET OF THE OFFICE OF THE CITY MAYOR OR FROM ANY AVAILABLE FUNDS OF THE CITY TREASURY.

Introduced by Councilors EDEN "Candy" A. MEDINA, WINSTON "Winnie" T. CASTELO, RAMON P. MEDALLA, ALLAN BUTCH T. FRANCISCO, VOLTAIRE GODOFREDO L. LIBAN III, and AIKO S. MELENDEZ.

WHEREAS, the late Teodoro O. Cuadra served Barangay Sangandaan as Barangay Kagawad during the time of then Quezon City Mayor Adelina S. Rodriguez and as Lupon Tagapamayapa during the time of then Quezon City Mayor Ismael A. Mathay, Jr.;

WHEREAS, on July 25, 2006 the late Kagawad Cuadra died due to acute Cardio Respiratory Arrest, Cardio Vascular Hypertension and Congestive Heart Failure;

WHEREAS, in recognition of Kagawad Cuadra's loyal, unselfish and dedicated public service to his barangay constituents and the city as well, his surviving heirs deserve financial assistance as a gesture of gratitude, respect and admiration.


