A RESOLUTION AMENDING THE TITLE AND DISPOSITIVE PORTION OF RESOLUTION NO. SP-4185, S-2008 BY CORRECTING THE NAME OF THE LATE FORMER BARANGAY KAGAWAD GEORGE DIMAGIBA DAVID, JR., TO JORGE DIMAGIBA DAVID, JR.

Introduced by Councilors EDEN "Candy" A. MEDINA, WINSTON "Winnie" T. CASTELO, RAMON P. MEDALLA, ALLAN BUTCH T. FRANCISCO, VOLTAIRE GODOFREDO L. LIBAN III and AIKO S. MELENDEZ.

WHEREAS, on June 2, 2008, the City Council adopted Resolution No. SP-4185, S-2008, entitled "A resolution granting financial assistance to the family of the late former Barangay Kagawad George Dimagiba David, Jr., of Barangay Culiat, Quezon City, in the amount of Forty Thousand Pesos (P40,000.00), chargeable against the appropriations for grants, subsidies and contributions under the 2008 annual budget of the office of the City Mayor or from any available funds in the city treasury;

WHEREAS, in the said resolution the first name of former Kagawad Jorge Dimagiba David, Jr., was incorrectly stated or misspelled to "George", hence, a purely typographical error or an honest mistake;

WHEREAS, to enable the bereaved family of Kagawad David, Jr., to claim or avail of the financial assistance granted under the aforesaid resolution, there is a need to correct the misspelled first name.
