A RESOLUTION STRONGLY URGING THE CITY MAYOR, HONORABLE FELICIANO R. BELMONTE, JR., TO EXTEND FINANCIAL ASSISTANCE TO THE JUNE 27, 2009 VICTIMS OF FIRE THAT BURNED THE RESIDENTIAL HOUSES OF THREE HUNDRED NINETY ONE (391) FAMILIES AT DUMPSITE MUSLIM AREA, SAN ROQUE II, BARANGAY BAGONG PAG-ASA, DISTRICT 1, QUEZON CITY, AT TWO THOUSAND PESOS (P2,000.00) PER FAMILY OWNER AND ONE THOUSAND (P1,000.00) PER FAMILY RENTER/SHARER WHICH SHALL BE TAKEN FROM THE CALAMITY OR EMERGENCY FUND OF THE CITY GOVERNMENT OR FROM ANY AVAILABLE SOURCE OF FUND THEREOF.

WHEREAS, on June 27, 2009 at Barangay Bagong Pag-Asa, specifically Dumpsite, Muslim Area, San Roque II, was hit by fire that burned the houses of Three Hundred Ninety One (391) families, who are now in direneed of financial assistance;

WHEREAS, because of this calamity, they are experiencing difficulties resulting from the incident;

WHEREAS, Section 458 (1) (iv) of the Local Government Code of 1991 empowered the Sangguniang Panlungsod to "adopt measures to protect the inhabitants of the City from the harmful effects of manmade or natural disasters and calamities, and to provide relief services and assistance for victims during and in the and aftermath of said disasters or calamities and in their return to productive livelihood following the said events.

Belmonte, Jr., to extend financial assistance to the June 27, 2009 victims of fire that burned the residential houses of Three Hundred Ninety One (391) families at Dumpsite, Muslim Area, San Roque II, Barangay Bagong Pag-asa, District 1, Quezon City, at Two Thousand Pesos (P2,000.00) per family/owner and One Thousand Pesos (P1,000.00) per family renter/sharer, which shall be taken from the Calamity or Emergency Fund of the City Government or from any available source of fund thereof.
