A RESOLUTION AUTHORIZING THE ISSUANCE OF A SPECIAL USE PERMIT TO MANILA KLEAN FUEL CORPORATION FOR THE CONSTRUCTION AND OPERATION OF AN AUTO LPG REFUELING STATION TO BE LOCATED AT NO. 293 P. TUAZON STREET, CUBAO, QUEZON CITY.

WHEREAS, petitioner Manila Klean Fuel Corporation, a duly registered business entity under Philippine laws, is applying a Special Use Permit (SUP) to be used for the construction and operation of an Auto LPG Refueling Station located at No. 293 P. Tuazon Street, Cubao, Quezon City;

WHEREAS, Fuel Stations are among the uses which require a Special Use Permit upon authorization from the Quezon City Council as provided in Ordinance No. SP-918, S-2000;

WHEREAS, Manila Klean Fuel Corporation has complied with requirements for the issuance of a Special Use Permit as required by the Quezon City Comprehensive Zoning Ordinance;

WHEREAS, the construction and operation of an Auto LPG Fuel Station will provide employment and promote economic development in the City.
