A RESOLUTION GRANTING FINANCIAL ASSISTANCE AMOUNTING TO FORTY THOUSAND PESOS (P40,000.00) TO THE BEREAVED FAMILY OF THE LATE RAUL ROBLES, BARANGAY KAGAWAD OF BARANGAY SALVACION, DISTRICT I, QUEZON CITY, TO BE TAKEN FROM THE APPROPRIATION FOR GRANTS, SUBSIDIES AND CONTRIBUTIONS UNDER THE 2009 ANNUAL BUDGET OF THE OFFICE OF THE CITY MAYOR OR FROM ANY AVAILABLE FUNDS OF THE CITY TREASURY.
