RESOLUTION NO. SP-4686s-2009

A RESOLUTION STRONGLY URGING THE CITY MAYOR, HONORABLE FELICIANO R. BELMONTE, JR., TO EXTEND FINANCIAL ASSISTANCE TO THE SEPTEMBER 2, 2009 VICTIMS OF FIRE THAT BURNED THE RESIDENTIAL HOUSES OF SEVEN (7) FAMILIES AT BAI COMPOUND, BARANGAY VASRA, DISTRICT 1, QUEZON CITY, AT TWO THOUSAND PESOS (P2,000.00) PER FAMILY OWNER AND ONE THOUSAND PESOS (P1,000.00) PER FAMILY RENTER/SHARER WHICH SHALL BE TAKEN FROM THE CALAMITY OR EMERGENCY FUND OF THE CITY GOVERNMENT OR FROM ANY AVAILABLE SOURCE OF FUND THEREOF.

WHEREAS, on September 2, 2009 at Barangay Vasra, specifically BAI Compound, a fire occurred that burned the houses of seven (7) families, who are now in dire need of financial assistance most especially from the City government;

WHEREAS, because of this calamity, they are experiencing difficulties resulting from the incident;

WHEREAS, it is the primary duty of the City government to extend assistance to its less fortunate constituents;

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to urge, as it does hereby urge the City Mayor, Honorable Feliciano R. Belmonte, Jr., to extend financial assistance to the September 2, 2009 victims of fire that burned the residential houses of seven (7) families at BAI Compound, Barangay Vasra, District 1, Quezon City, at Two Thousand Pesos (P2,000.00) per family owner and One Thousand Pesos (P1,000.00) per family renter/sharer, which shall be taken from the calamity or emergency fund of the City government or from any available source of fund thereof.
