A RESOLUTION GRANTING FINANCIAL ASSISTANCE AMOUNTING TO FORTY THOUSAND PESOS (P40,000.00) TO THE BEREAVED FAMILY OF THE LATE RAMONCITO "MONCHING" REYES, BARANGAY KAGAWAD OF BARANGAY STA. TERESITA, DISTRICT I, QUEZON CITY, TO BE TAKEN FROM THE APPROPRIATION FOR GRANTS, SUBSIDIES AND CONTRIBUTIONS UNDER THE 2009 ANNUAL BUDGET OF THE OFFICE OF THE CITY MAYOR OR FROM ANY AVAILABLE FUNDS OF THE CITY TREASURY.
