WHEREAS, SW Core Petroleum Inc., a duly established and registered business corporation under Philippine laws, is applying for the issuance of a special use permit for the construction and operation of a gasoline pumping station at Quezon Avenue, Barangay Santa Cruz, Quezon City;

WHEREAS, one of the provisions in Ordinance No. SP-918,S-2000, known as the Quezon City Comprehensive Zoning Ordinance requires that gasoline pumping stations must acquire Special Use Permit prior to construction and operation;

WHEREAS, SW Core Petroleum Inc. entered into an agreement with NAIADSS Corporation which is previously operating an LPG refilling station at the said address having been issued a Special Use Permit by the City Planning and Development Office of the City docketed as No. SUP-07-121 dated March 22, 2007;

WHEREAS, SW Core and NAIADSS corporation entered into an agreement for a Deed of Assignment and transfer of rights for the interest and foregoing business operation of this station on June 10, 2009;

WHEREAS, SW Core which has continued the operation of the LPG refilling station and is expanding their operation to include a gasoline pumping station at the same location;

WHEREAS, SW Core has complied with all the requirements needed to satisfy the issuance of the Special Use Permit.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize the issuance of a Special Use Permit to SW Core Petroleum, Inc. for the construction and operation of a gasoline pumping station at Quezon Avenue, Barangay Sta. Cruz, Quezon City.
