RESOLUTION NO. SP **4730** S-2009

A RESOLUTION STRONGLY URGING THE CITY MAYOR, HONORABLE FELICIANO R. BELMONTE, JR., TO EXTEND FINANCIAL ASSISTANCE TO THE SEPTEMBER 14, 2009 VICTIMS OF FIRE THAT BURNED THE RESIDENTIAL HOUSES OF THIRTEEN (13) FAMILIES AT NO. 20-22 HALCON II, BARANGAY STA. TERESITA, DISTRICT I, QUEZON CITY, AT TWO THOUSAND PESOS (P2,000.00) PER FAMILY OWNER AND ONE THOUSAND PESOS (P1,000.00) PER FAMILY RENTER/SHARER WHICH SHALL BE TAKEN FROM THE CALAMITY OR EMERGENCY FUND OF THE CITY GOVERNMENT OR FROM ANY AVAILABLE SOURCE OF FUND THEREOF.

WHEREAS, on September 14, 2009 at Barangay Sta. Teresita, specifically No. 20-22 Halcon II, a fire occurred that burned the houses of thirteen (13) families who are now in dire need of financial assistance, especially from the City government;

WHEREAS, because of this calamity, they are experiencing difficulties resulting from the incident;


WHEREAS, it is the primary duty of the City government to extend assistance to its less fortunate constituents.


NOW, THEREFORE,
