RESOLUTION NO. SP4771, S-2009

A RESOL UTION STRONGLY URGING THE CITY MAYOR, HONORABLE FELICIANO R. BELMONTE, JR., TO EXTEND FINANCIAL ASSISTANCE TO THE OCTOBER 29, 2009 VICTIMS OF FIRE THAT BURNED THE RESIDENTIAL HOUSES OF EIGHTY (80) FAMILIES AT APOLLO STREET CORNER GENERAL WOOD STREET, BARANGAY DEL MONTE, DISTRICT 1, QUEZON CITY, AT TWO THOUSAND PESOS (P2,000.00) PER FAMILY OWNER AND ONE THOUSAND PESOS (P1,000.00) PER FAMILY RENTER/SHARER WHICH SHALL BE TAKEN FROM THE CALAMITY OR EMERGENCY FUND OF THE CITY GOVERNMENT OR FROM ANY AVAILABLE SOURCE OF FUND THEREOF.

WHEREAS, because of this calamity, they are experiencing difficulties resulting from the incident;

WHEREAS, it is the primary duty of the city government to extend assistance to its less fortunate constituents.

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to urge, as it does hereby strongly urge, the City Mayor, Honorable Feliciano R. Belmonte. Jr., to extend financial assistance to the October 29, 2009 victims of fire that burned the residential houses of Eighty (80) families at Apollo Street corner General Wood Street, Barangay Del Monte, District 1, Quezon City, at Two Thousand Pesos (P2,000.00) per family owner and One Thousand Pesos (P1,000.00) per family renter/sharer, which shall be taken from the calamity or emergency fund of the City Government or from any available source of fund thereof.'
