A RESOLUTION GRANTING FINANCIAL ASSISTANCE TO THE BEREAVED FAMILY OF THE LATE FORMER BARANGAY KAGAWAD EDUARDO VALENZUELA OF BARANGAY BAGBAG, QUEZON CITY, IN THE AMOUNT OF THIRTY THOUSAND PESOS (P30,000.00), CHARGEABLE AGAINST THE APPROPRIATION FOR GRANTS, SUBSIDIES AND CONTRIBUTIONS UNDER THE 2010 ANNUAL BUDGET OF THE OFFICE OF THE CITY MAYOR OR FROM ANY AVAILABLE FUNDS OF THE CITY TREASURY.

WHEREAS, during his incumbency, Kagawad Valenzuela served with utmost dedication, honesty, loyalty and competence which greatly contributed to the development and progress of Barangay Bagbag, as well as improved the lives of the residents therein;


