A RESOLUTION AUTHORIZING THE ISSUANCE OF A SPECIAL USE PERMIT TO BMS TAGORDA CO., INC., FOR THE CONSTRUCTION AND OPERATION OF A GASOLINE REFILLING AND SERVICE STATION AT NO. 1002 A. BONIFACIO AVENUE, BARANGAY BALINGASA, BALINTAWAK, QUEZON CITY (NORTHBOUND OF BONIFACIO AVENUE).

WHEREAS, BMS Tagorda Co., Inc. a duly registered business entity under Philippines Laws, with office address at No. 943 A. Bonifacio Avenue, Barangay Balingasa, Balintawak, Quezon City, is applying for the issuance of a Special Use Permit (SUP) for the construction and operation of a gasoline refilling and service station to be located at No. 1002 A. Bonifacio Avenue, Barangay Balingasa, Balintawak, Quezon City;

WHEREAS, the construction and operation of a gasoline refilling and service station are among the uses which require a special use permit as provided for under Ordinance No. SP-918, S-2000, otherwise known as the Quezon City Comprehensive Zoning Ordinance of 2000, as amended;

WHEREAS, the Sangguniang Barangay of Barangay Balingasa and the residents therein interpose no objection to the said gasoline refilling and service station;

WHEREAS, the applicant has complied with the requirements for the issuance of a Special Use Permit pursuant to the said ordinance;
