A RESOLUTION GRANTING FINANCIAL ASSISTANCE TO THE BEREAVED FAMILY OF THE LATE FORMER BARANGAY KAGAWAD DANILO PASCUAL OF BARANGAY BAESA, QUEZON CITY, IN THE AMOUNT OF THIRTY THOUSAND PESOS (PHP30,000.00) CHARGEABLE AGAINST THE APPROPRIATION FOR GRANTS, SUBSIDIES AND CONTRIBUTIONS UNDER THE 2010 ANNUAL BUDGET OF THE OFFICE OF THE CITY MAYOR OR FROM ANY AVAILABLE FUNDS OF THE CITY TREASURY.


