A RESOLUTION AUTHORIZING THE ISSUANCE OF A SPECIAL USE PERMIT TO KLEAN FUEL AUTO LPG REFILLERS INCORPORATED FOR THE CONSTRUCTION AND OPERATION OF AN AUTO LPG REFUELING STATION TO BE LOCATED AT NO. 370 COMMONWEALTH AVENUE, BARANGAY OLD BALARA, QUEZON CITY.

WHEREAS, petitioner Klean Fuel Auto LPG Refillers Inc., a business entity duly registered under Philippine laws, is applying for a Special Use Permit (SUP) to be used for the construction and operation of an Auto LPG Refueling Station located at No. 370 Commonwealth Avenue, Barangay Old Balara, Quezon City;

WHEREAS, fuel stations are among the uses which require a Special Use Permit upon authorization from the Quezon City Council as provided in Ordinance No. SP-918, S-2000, otherwise known as the Quezon City Comprehensive Zoning Ordinance of 2000;

WHEREAS, Klean Fuel Auto LPG Refillers Inc. has complied with the necessary requirements for the issuance of a Special Use Permit as mandated by the Quezon City Comprehensive Zoning Ordinance;

WHEREAS, the construction and operation of an Auto LPG Fuel Station will provide employment and promote economic development in the City.
