A RESOLUTION GRANTING FINANCIAL ASSISTANCE TO THE FAMILY AND SURVIVING HEIRS OF THE LATE SANGGUNIANG KABATAAN KAGAWAD JOSHUA PAUL Y. MARIANO OF BARANGAY PARAISO, DISTRICT I, THIS CITY, IN THE AMOUNT OF THIRTY THOUSAND PESOS (P30,000.00) IN RECOGNITION OF HIS DEDICATED AND EXEMPLARY SERVICE TO HIS BARANGAY AND TO THE CITY, TO BE CHARGED AGAINST THE APPROPRIATION FOR GRANTS, SUBSIDIES AND CONTRIBUTIONS OF THE 2010 ANNUAL BUDGET OF THE OFFICE OF THE CITY MAYOR OR FROM ANY AVAILABLE FUNDS OF THE CITY TREASURY.
