RESOLUTION NO. SP- 5047 , S-2010

A RESOLUTION AUTHORIZING THE ISSUANCE OF A CERTIFICATE OF EXCEPTION TO SM DEVELOPMENT CORPORATION FOR THE (43)CONSTRUCTION OF \boldsymbol{A} **FORTY THREE STOREY** COMMERCIAL/RESIDENTIAL CONDOMINIUM BUILDING WITH ROOFDECK AND PENTHOUSE NAMED "MEZZA RESIDENCE 2" LOCATED AT AURORA BOULEVARD, STA. MESA, BARANGAY DOÑA IMELDA. OUEZON CITY. ALLOWING DEVIATION FROM THE RESTRICTIONS OF THE QUEZON CITY COMPREHENSIVE ZONING ORDINANCE NO. SP-918, S-2000, AS AMENDED.

WHEREAS, SM Development Corporation is applying for a Certificate of Exception for the construction of a Forty Three (43) storey commercial/residential condominium building with Roofdeck and Penthouse located at Aurora Boulevard, Sta. Mesa, Barangay Doña Imelda, Quezon City;

WHEREAS, the proposed Project will not adversely affect public health, safety and welfare and is in keeping with the general pattern of development in the community;

WHEREAS, in accordance with the provisions of Article V, Article VIII, Section 3 and Article VI, Section 3, Section 4, Section 8 and Section 11 of Ordinance No. SP-918, S-2000 and its Implementing Rules and Regulations, an exception is required for the construction of the said proposed project.
