A RESOLUTION AUTHORIZING THE ISSUANCE OF A CERTIFICATE OF EXCEPTION TO RJM MERCHANDISE LINK INCORPORATED FOR THE CONSTRUCTION OF A TWELVE (12) STOREY COMMERCIAL/RESIDENTIAL MIXED-USED BUILDING WITH PENTHOUSE AND ROOFDECK NAMED "VOYERY PLAZA" LOCATED AT LOT 1A BLOCK 10 N.S. AMORANTO SR. AVENUE CORNER SPEAKER PEREZ STREET, BARANGAY MAHARLIKA, QUEZON CITY, ALLOWING DEVIATION FROM THE RESTRICTIONS OF THE QUEZON CITY COMPREHENSIVE ZONING ORDINANCE NO. SP-918, S-2000, AS AMENDED.
