A RESOLUTION AUTHORIZING THE ISSUANCE OF A CERTIFICATE OF EXCEPTION TO MR. ROGERIO B. BAUSA AND THELMA B. BAUSA FOR THE CONSTRUCTION OF AN EIGHT (8) DOOR APARTMENT LOCATED AT BLOCK 1 LOT 6A AND LOT 8B, AGOO STREET, NEW HAVEN VILLAGE, BARANGAY KALIGAYAHAN, QUEZON CITY, ALLOWING DEVIATION FROM THE RESTRICTIONS OF THE QUEZON CITY COMPREHENSIVE ZONING ORDINANCE NO. SP-918, S-2000, AS AMENDED.

WHEREAS, the Barangay Council of Barangay Kaligayahan and its residents interposed no objection to the said project;

WHEREAS, the proposed project will not adversely affect public health, safety and welfare and is in keeping with general pattern of development in the community;
