RESOLUTION NO. SP. 5330 , S-2011

A RESOLUTION AUTHORIZING THE ISSUANCE OF A CERTIFICATE OF EXEMPTION TO MR. ALEX YAP CHO TY FOR THE CONSTRUCTION OF A THREE (3)-UNIT ONE (1)-STOREY WAREHOUSE BUILDING LOCATED AT LOT 2-A-1 HIMALAYAN ROAD, BANLAT, BARANGAY PASONG TAMO, NOVALICHES, QUEZON CITY, ALLOWING DEVLATION FROM THE RESTRICTIONS OF THE QUEZON CITY COMPREHENSIVE ZONING ORDINANCE NO. SP-918, S-2000, AS AMENDED.
