A RESOLUTION AUTHORIZING THE ISSUANCE OF A CERTIFICATE OF EXCEPTION TO ABS-CBN FOUNDATION, INC., FOR THE PROPOSED CONSTRUCTION OF ONE (1)-STOREY WAREHOUSE WITH MEZZANINE AND ATTIC LOCATED AT LOT 2-C/BLK. WT-39, EXAMINER STREET, BARANGAY WEST TRIANGLE, QUEZON CITY, ALLOWING DEVIATION FROM THE RESTRICTIONS OF THE QUEZON CITY COMPRIHENSIVE ZONING ORDINANCE NO. SP-918, S-2000, AS AMENDED.

WT-39, Examiner Street, Barangay West Triangle, Quezon City, allowing deviation from the restrictions of the Quezon City Comprehensive Zoning Ordinance No. SP-918, S-2000, as am-rided.
