WHEREAS, Pocket Aces Game Depot, a duly registered entity, is applying for a Special Permit from the City Council as a condition precedent for the issuance of business permit to operate an e-Games (PEG) pursuant to Resolution No. SP-1705, S-2001;

WHEREAS, the Philippine Amusement and Gaming Corporation (PAGCOR) granted Pocket Aces Game Depot an authority to operate an e-Games (PEGS) at Ground Floor, ETON Centris Station, EDSA corner Quezon Avenue, Barangay Pinyahan, Quezon City;

WHEREAS, Barangay Pinyahan issued a Barangay Clearance to Pocket Aces Game Depot for the E-Games at said location;

WHEREAS, Republic Act No. 7160, known as the Local Government Code of the Philippines authorizes the City Council to enact ordinances, issue permits and grant franchise within its jurisdiction.

NOW, THEREFORE,

BE IT RESCLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to grant, as it does hereby grant a Special Permit to Pocket Aces Depot to operate an e-Games (PEGS) at Ground Floor, ETON Centris Station, EDSA corner Quezon Avenue, Baracyny Pinyahan, Quezon City, subject to the rules and regulations promulgated by the Philippine Amusement and Gaming Corporation (PAGCOR).

RESOLVED, FURTHER, that the authority herein granted shall be for a period of five (5) years only, however, it may be renewed by the City Council.
