RESOLUTION NO. SP- 5384 , S-2011

A RESOLUTION AUTHORIZING THE ISSUANCE OF A CERTIFICATE OF EXCEPTION TO DMCI-PROJECT DEVELOPERS, INC., FOR THE CONSTRUCTION OF TWO (2) FORTY (40)-STOREY RESIDENTIAL CONDOMINIUM WITH PENTHOUSE, ROOF DECK AND THREE (3) BASEMENT PARKING NAMED "ZINNIA TOWERS" LOCATED AT LOT 280-B-4-C-4-C-1 TO 280-B-4-C-4-C9, SPECIFICALLY AT NO. 1211 EDSA, BARANGAY KATIPUNAN, QUEZON CITY, ALLOWING DEVIATION FROM THE RESTRICTIONS OF THE QUEZON CITY COMPREHENSIVE ZONING ORDINANCE NO. SP-918, S-2000, AS AMENDED.

BE IT RESOLVED BY THE CITY COUNCIL, OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize the issuance of a Certificate of Exception as provided for in Article V, Section 8, Article VIII, Section 3, and Article VI Section 3, Section 4, Section 8 and Section 11 of Ordinance No. SP-918, S-2000 as amended, otherwise known as the Quezon City Comprehensive Zoning Ordinance and its Implementing Rules and Regulations to DMCI - Project Developers, Inc., for the construction of a two (2) forty (40)-storey residential Condominium with Penthouse, Roof Deck and three (3) Basement Parking named "Zinnia Towers" located at Lot 280-B-4-C-4-C-1 to 280-B-4-C-4-C9, specifically at No. 1211 EDSA, Barangay Katipunan, Quezon City.
