A RESOLUTION AUTHORIZING THE ISSUANCE OF A CERTIFICATE OF EXCEPTION TO AMAIA LAND CORPORATION FOR THE CONTRUCTION OF THREE (3) THIRTY SIX (36)-STOREY RESIDENTIAL COMPINIUM COMPLEX WITH ROOF DECK AND MACHINE ROOM NAMED "AMAIA SKIES CUBAO" LOCATED AT 5TM AVENUE CORNER P.
