**A RESOLUTION GRANTING FINANCIAL ASSISTANCE TO THE BEREAVED FAMILY OF THE LATE FORMER BARANGAY KAGAWAD ILLUMINADA G. TAPIADOR, BARANGAY VASRA, QUEZON CITY, WHO DIED ON JUNE 3, 2011, IN THE AMOUNT OF FORTY THOUSAND PESOS (P40,000.00), TO BE CHARGED AGAINST THE APPROPRIATION FOR SUBSIDIES AND DONATIONS UNDER THE 2011 ANNUAL BUDGET OF THE OFFICE OF THE CITY MAYOR OR FROM ANY AVAILABLE FUNDS OF THE CITY TREASURY.**
