A RESOLUTION AUTHORIZING THE ISSUANCE OF A CERTIFICATE OF EXCEPTION TO WILSON SO & ROSEMARIE SO FOR THE CONSTRUCTION OF A FOUR (4)-UNIT/THREE (3)-STOREY RESIDENCES LOCATED AT LOT 12/SUB-BLOCK 13 13TH STREET, BARANGAY MARIANA, QUEZON CITY, ALLOWING DEVIATION FROM THE RESTRICTIONS OF THE QUEZON CITY COMPREHENSIVE ZONING ORDINANCE NO.
