A RESOLUTION AUTHORIZING THE ISSUANCE OF A CERTIFICATE OF EXCEPTION TO FIANCHETTO REALTY DEV'T. CORP., FOR THE CONSTRUCTION OF A THREE (3)-STOREY EIGHTEEN (18) RESIDENTIAL UNITS WITH ATTIC LOCATED AT L6 B3 DON CARLOS STREET, DON ANTONIO HEIGHTS SUBDIVISION, BARANGAY HOLY SPIRIT, QUEZON CITY ALLOWING DEVIATION FROM THE RESTRICTIONS OF THE QUEZON CITY COMPREHENSIVE ZONING ORDINANCE NO. SP-918, S-2000, AS AMENDED.
