A RESOLUTION AMENDING RESOLUTION NO. SP-5330, S-2011, ENTITLED: A RESOLUTION AUTHORIZING THE ISSUANCE OF A CERTIFICATE OF EXEMPTION TO MR. ALEX YAP CHO TY FOR THE CONSTRUCTION OF A FIVE (5) UNIT ONE (1) STOREY WAREHOUSE BUILDING LOCATED AT LOT 2-A-1 HIMALAYAN ROAD, BANLAT, BUILDING LOCATED AT LOT 2-A-1 HIMALAYAN ROAD, BANLAT, BARANGAY PASONG TAMO, NOVALICHES, QUEZON CITY, ALLOWING DEVIATION FROM THE RESTRICTIONS OF THE QUEZON CITY COMPREHENSIVE ZONING ORDINANCE NO. SP-918, S-2000, AS AMENDED.
