A RESOLUTION AMENDING RESOLUTION NO. SP-5306, S-2011, ENTITLED: A RESOLUTION AUTHORIZING THE ISSUANCE OF A CERTIFICATE OF EXCEPTION TO SKY WEALTH LAND HOLDINGS, INC., "WINLAND TOWER RESIDENCES 5" FOR THE CONSTRUCTION OF A THIRTY EIGHT (38) STOREY COMMERCIAL/RESIDENTIAL BUILDING WITH ROOF DECK, LOWER GROUND FLOOR AND 2-BASEMENT PARKING LOCATED AT LOT 5 AND 6, BLOCK 11-B GRANADA ST.
