RESOLUTION NO. SP- 5452 , S-2012

A RESOLUTION AUTHORIZING THE ISSUANCE OF A CERTIFICATE OF EXCEPTION TO DMCI PROJECT DEVELOPERS, INC. FOR THE CONSTRUCTION OF A THIRTY ONE (31) STOREY RESIDENTIAL CONDOMINIUM WITH ROOF DECK, LOWER AND UPPER PENTHOUSE AND FIVE (5) BASEMENT PARKING TO BE NAMED AS "ONE CASTILLA PLACE" LOCATED AT LOTS 8, 9, 10, BLOCK 10-B, LOTS 3-A & 3-B-7 CASTILLA STREET, BARANGAY VALENCIA QUEZON CITY, ALLOWING DEVIATION FROM THE RESTRICTIONS OF THE QUEZON CITY COMPREHENSIVE ZONING ORDINANCE NO. SP-918, S-2000, AS AMENDED.

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize the issuance of a Certificate of Exception as provided for in Article IV, Section 2 and Article VI, Section 4 and Section 11 and Article VIII of Ordinance No. SP-918, S-2000, otherwise known as the Quezon City Comprehensive Zoning Ordinance and its Implementing Rules and Regulations to DMCI Project Developers, Inc., for the construction of a Thirty One (31) Storey Residential Condominium with Roof deck, lower and upper Penthouse and Five (5) Basement Parking to be named as "One Castilla Place" located at Lots 8, 9, 10, Block 10-B, Lots 3-A & 3-B-7 Castilla Street, Barangay Valencia, Quezon City, allowing deviation from the restrictions of the Quezon City Comprehensive Zoning Ordinance No. SP-918, S-2000, as amended.
