WHEREAS, Merlyn Ferran Martirez is applying for a Special Permit from the City Council as a condition precedent for the issuance of Business Permit to operate a Bingo Boutique pursuant to Resolution No. SP-1705, S-2001;

WHEREAS, the Philippine Amusement and Gaming Corporation (PAGCOR) granted Merlyn Ferran Martirez an authority to operate a bingo boutique at the 2/f MSK Building, No. 241 Visayas Avenue, Barangay Tandang Sora, Quezon City;

WHEREAS, Barangay Tandang Sora issued a Barangay Clearance to Merlyn Ferran Martirez for the operation of the Bingo Boutique at said location;

WHEREAS, Republic Act No. 7160, otherwise known as the Local Government Code of 1991, authorizes the City Council to enact ordinances, issue permits and grant franchises within its jurisdiction.

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to grant, as it does hereby grant a Special Permit to Merlyn Ferran Martirez to operate a Bingo Boutique at 2/F MSK Building, No. 241 Visayas Avenue, Barangay Tandang Sora, Quezon City, subject to the rules and regulations promulgated by the Philippine Amusement and Gaming Corporation (PAGCOR).

RESOLVED, FURTHER, that the authority herein granted shall be for a period of three (3) years only; however, it may be renewed by the City Council.

RESOLVED, FINALLY, that this Resolution shall take effect fifteen (15) days after its approval.
