**A RESOLUTION GRANTING A SPECIAL PERMIT TO MERLYN FERRAN MARTIREZ TO OPERATE AN ELECTRONIC BINGO OR EBINGO (BINGO BOUTIQUE) AT NO. 649 BANAWE AVENUE, BARANGAY ST. PETER, QUEZON CITY, SUBJECT TO THE RULES AND REGULATIONS PROMULGATED BY THE PHILIPPINE AMUSEMENT AND GAMING CORPORATION (PAGCOR).**

*WHEREAS, Merlyn Ferran Martirez is applying for a Special Permit from the City Council as a condition precedent for the issuance of Business Permit to operate an Electronic Bingo or eBingo (Bingo Boutique) pursuant to Resolution No. SP-1705, S-2001;*

*WHEREAS, the Philippine Amusement and Gaming Corporation (PAGCOR) granted Merlyn Ferran Martirez an authority to operate an Electronic Bingo or eBingo (Bingo Boutique) at No. 649 Banawe Avenue, Barangay St. Peter, Quezon City;*

*WHEREAS, Barangay St. Peter issued a Barangay Clearance to Merlyn Ferran Martirez for the operation of the electronic bingo or eBingo at said location;*

*WHEREAS, Republic Act No. 7160, otherwise known as the Local Government Code of 1991 authorizes the City Council to enact ordinances, issue permits and grant franchise within its jurisdiction.*

**NOW, THEREFORE,**


**BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED,** to grant, as it does hereby grant a Special Permit to Merlyn Ferran Martirez to operate an Electronic Bingo or eBingo (Bingo Boutique) at No. 649 Banawe Avenue, Barangay St. Peter, Quezon City, subject to the rules and regulations promulgated by the Philippine Amusement and Gaming Corporation (PAGCOR).

**RESOLVED FURTHER,** that PHILWEB and their respective share through an accredited operator shall remit to the City treasurer in lieu of all business taxes, a franchise fee of fifty seven percent (57%) of one percent (1%) of the gross revenue of herein grantee which shall be made payable to the City Treasurer during the life time of this measure.


**RESOLVED, FURTHERMORE,** that the authority herein granted shall be for a period of three (3) years only, however, it may be renewed by the City Council.

**RESOLVED, FINALLY,** that this Resolution shall take effect fifteen (15) days after its approval.
