A RESOLUTION AUTHORIZING THE ISSUANCE OF A CERTIFICATE OF EXCEPTION TO GREEN EARTH BUILDINGS AND HOMES CORP. FOR THE CONSTRUCTION OF AN EIGHT (8)-STOREY RESIDENTIAL/COMMERCIAL CONDOMINIUM WITH PENTHOUSE AND BASEMENT PARKING NAMED "THE MIDCITY SUITES" LOCATED AT LOT 1-A MANGGA ROAD, BARANGAY KAUNLARAN, QUEZON CITY, ALLOWING DEVIATION FROM THE RESTRICTIONS OF THE QUEZON CITY COMPREHENSIVE ZONING ORDINANCE NO. SP-918, S-2000, AS AMENDED.
