A RESOLUTION AUTHORIZING THE ISSUANCE OF A CERTIFICATE OF EXCEPTION TO ETON PROPERTIES PHILIPPINES, INC., FOR THE CONSTRUCTION OF "MIREN AT ROOSEVELT" THE PROJECT CONSIST OF FOUR (4) TOWERS INTERCONNECTION BY A COMMON PODIUM; A TWO (2)-TOWER EIGHTEEN (18)-STOREY AND TWO (2) TOWER TWENTY FOUR (24)-STOREY RESIDENTIAL CONDOMINIUM LOCATED ALONG ROOSEVELT AVENUE, SAN FRANCISCO DEL MONTE, QUEZON CITY, ALLOWING DEVIATION FROM THE RESTRICTIONS OF THE QUEZON CITY COMPREHENSIVE ZONING ORDINANCE NO. SP-918, S-2000, AS AMENDED.
