A RESOLUTION AUTHORIZING THE ISSUANCE OF A CERTIFICATE OF EXCEPTION TO THE REGALIA GROUP CORPORATION FOR THE CONSTRUCTION OF "REGALIA PARK RESIDENCES", A THIRTY FIVE (35)-STOREY COMMERCIAL AND RESIDENTIAL CONDOMINIUM WITH SIX (6) BASEMENT PARKING LEVEL AND ROOFDECK LOCATED AT LOTS 1 AND 4 AT NO. 150 P. TUAZON BOULEVARD, CUBAO, BARANGAY SOCORRO, QUEZON CITY, ALLOWING DEVIATION FROM THE RESTRICTIONS OF THE QUEZON CITY COMPREHENSIVE ZONING ORDINANCE NO. SP-918, S-2000, AS AMENDED.

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize the issuance of a Certificate of Exception as provided for in Article V, Article VI Sections 4 and 11 (f), Article VIII Section 3 and Article IX Section 18 of Ordinance No. SP-918, S-2000, otherwise known as the Quezon City Comprehensive Zoning Ordinance and its Implementing Rules and Regulations to Regalia Group Corporation for the construction of "Regalia Park Residences", a thirty-five (35)-storey commercial and residential Condominium with six (6) basement parking level and roofdeck located at Lots 1 and 4 at No. 50 P. Tuazon Boulevard, Cubao, Barangay Socorro, Quezon City, allowing deviation from the restrictions of the Quezon City Comprehensive Zoning Ordinance No. SP-918, S-2000, as amended.
