A RESOLUTION AUTHORIZING THE ISSUANCE OF A CERTIFICATE OF EXCEPTION TO MEGA WORLD CORPORATION FOR THE CONSTRUCTION OF A SIX (6) - SIX (6)-STOREY RESIDENTIAL BUILDINGS WITH TWO (2) BASEMENT AND ROOFDECK NAMED "GOLFHILL GARDENS" LOCATED AT MANOTOK DRIVE, CAPITOL HILLS, BARANGAY MATANDANG BALARA, QUEZON CITY, ALLOWING DEVIATION FROM THE RESTRICTIONS OF THE QUEZON CITY COMPREHENSIVE ZONING ORDINANCE NO. SP-918, S-2000, AS AMENDED.
