A RESOLUTION AUTHORIZING THE ISSUANCE OF A CERTIFICATE OF EXCEPTION TO SUNTRUST PROPERTIES, INC., FOR THE CONSTRUCTION OF A THIRTY TWO (32)-STOREY RESIDENTIAL/COMMERCIAL CONDOMINIUM WITH TWO (2) BASEMENT PARKING AND ROOFDECK NAMED "CAPITOL PLAZA" LOCATED AT LOT PCS-00-000629 MATALINO STREET, BARANGAY CENTRAL, QUEZON CITY, ALLOWING DEVIATION FROM THE RESTRICTIONS OF THE QUEZON CITY COMPREHENSIVE ZONING ORDINANCE NO. SP-918, S-2000, AS AMENDED.
