A RESOLUTION AUTHORIZING THE ISSUANCE OF A CERTIFICATE OF EXCEPTION TO AVIDA LAND CORPORATION FOR THE CONSTRUCTION OF A TWO (2) FIFTEEN (15)-STOREY RESIDENTIAL/COMMERCIAL BUILDING WITH ROOFDECK (TOWER 1 AND 2) AND ONE (1) EIGHTEEN (18)-STOREY RESIDENTIAL BUILDING WITH ROOFDECK (TOWER 3) LOCATED AT LOT 2 QUIRINO HIGHWAY, BARANGAY PASONG PUTIK PROPER, QUEZON CITY, ALLOWING DEVIATION FROM THE RESTRICTIONS OF THE REVISED QUEZON CITY COMPREHENSIVE ZONING ORDINANCE NO.
