WHEREAS, Ordinance No. SP-918, S-2000, as amended, provides that a Special Use Permit is required for operating a taxi garage accommodating more than six (6) taxi units;

WHEREAS, Basic Transport Management Corporation, a duly registered business entity under Philippine law, is applying for a Special Use Permit for the operation of its taxi garage located at No. 65 K-9th corner K-10th Street, Barangay East Kamias, Quezon City;

WHEREAS, the applicant corporation is one of the largest taxi operators of Metro Manila; it has maintained and operated its business for several years, and is known as a devoted taxpayer that will significantly provide employment to the residents and revenue of our beloved city;
