RESOLUTION NO. SP- 5969 , S-2014

A RESOLUTION AUTHORIZING THE QUEZON CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO PURCHASE ONE (1) UNIT OF MOTOR VEHICLE IN THE AMOUNT OF SIX HUNDRED SEVENTY THOUSAND PESOS (PHP670,000.00), INTENDED FOR MONITORING THE PROGRAMS AND PROJECTS OF THE OFFICE OF COUNCILOR JESUS MANUEL C. SUNTAY.

WHEREAS, under Section 2, Article I of Republic Act No. 9184, otherwise known as the Government Procurement Reform Act, it is the policy of the State to promote the ideals of good governance in all its branches, departments, agencies, subdivisions and instrumentalities including government-owned and controlled corporations and local government units;

WHEREAS, to ensure the expeditious delivery of quality public service and to make the members of the City Council more closer to its constituents through monitoring of projects and immersion programs, there is an imperative need to provide them the necessary motor vehicles.

WHEREAS, the Office of Councilor Jesus Manuel C. Suntay desires to procure one (1) unit of passenger van to be used for the aforesaid purposes, specifically described as follows:

- APV PASSENGER VAN M/T (DUAL A/C):
- Equipped with 1.6L SOHC 16 Valve with multi-point injection and distributor-less ignition system;
- Minimum output: 91 HP @ 5,750rpm;
- Max torque: 127 Nm @ 4,500rpm
- Brakes Front: Ventilated discs rear: Leading and Trailing Drums;
- Transmission: 5-speed Manual Transmission;
- Front Suspension: McPherson strut and coil spring;
- Rear Suspension: Rigid Axle & Leaf Spring;
- Tires/Wheels: Steel Rim Wheels 185/80R14;
- Steering Wheel: 2 Spoke;
- Fuel Tank Capacity: 43 liters;
- Steering System: Power Rack & Pinion:
- Overall length: 4,155mm: 1,655mm;
- Overall height: 1,855mm;
- Ground Clearance: 1700mm.

WHEREAS, pursuant to Section 455 (b) (1) (vi) of Republic Act. No. 7160, otherwise known as the Local Government Code of 1991, the City Mayor shall represent the city in all its business transactions and sign in its behalf all bonds, contracts and obligations and such other documents upon the authority of the Sangguniang Panlungsod or pursuant to a law or ordinance.

NOW. THEREFORE.

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize the City Mayor, Honorable Herbert M. Bautista, to purchase one (1) unit of motor vehicle in the amount of Six Hundred Seventy Thousand Pesos (PHP670,000.00), intended for monitoring the programs and projects of the Office of Councilor Jesus Manuel C. Suntay.
