RESOLUTION NO. SP- 5977 , S-2014

A RESOLUTION AUTHORIZING THE QUEZON CITY GOVERNMENT THROUGH MAYOR HERBERT M. BAUTISTA, TO GRANT FINANCIAL ASSISTANCE IN THE AMOUNT OF TWENTY ONE MILLION NINE HUNDRED FIFTY NINE THOUSAND SIXTY EIGHT PESOS AND SIXTY CENTAVOS (P21,959,068.60) TO THE MUNICIPALITY OF SANTA FE, LEYTE, FOR THE RESTORATION AND RECONSTRUCTION OF THE MUNICIPAL HALL COMPLEX, DESTROYED BY TYPHOON YOLANDA (HAIYAN), SUBJECT TO EXISTING LAWS, RULES AND REGULATIONS.

WHEREAS, the City Government is empowered under Section 458 (1), (IV) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, to "adopt measures to protect the inhabitants of the city from the harmful effects of man-made or natural disasters and calamities and to provide relief services and assistance for victims during and in the aftermath of said disasters or calamities and their return to productive livelihood following said events";

WHEREAS, Typhoon "Haiyan or Yolanda" struck the Philippines and has been regarded as the most powerful storm to make landfall in recorded history and the worst hit provinces were Leyte and Eastern Samar;

WHEREAS, Typhoon "Yolanda" was a destructive natural calamity which took several lives, and destroyed millions worth of agricultural products and properties of our countrymen especially in the provinces of Leyte and Eastern Samar;

WHEREAS, the Municipality of Santa Fe, Leyte issued Resolution No. 14-05, Series 2014, seeking financial assistance from the Quezon City Government for the restoration and reconstruction of its Municipal Hall Complex, to wit:

- a. The Main Building (Old Town Hall)
- b. The Sangguniang Bayan Building;
- c. The Mayor's Office Building; and
- d. The Municipal Public Market.

WHEREAS, the Quezon City Government expressed its sympathy for the victims of Typhoon "Yolanda", most especially for the provinces of Leyte and Eastern Samar;

WHEREAS, the Quezon City Government through Mayor Herbert M. Bautista is donating the amount of Twenty One Million Nine Hundred Fifty Nine Thousand Sixty Eight Pesos and Sixty Centavos (Php21,959,068.60) to be taken from the General Fund by virtue of Ordinance No. SP-2234, Series of 2013, as financial assistance specifically for the purpose of the restoration and reconstruction of the Municipal Hall Complex, as stated, by the Municipality of Santa Fe, Leyte.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize the City Mayor, Honorable Herbert M. Bautista, in behalf of the Quezon City Government, to grant financial assistance in the amount of Twenty One Million Nine Hundred Fifty Nine Thousand Sixty Eight Pesos and Sixty Centavos (P21,959,068.60) to the Municipality of Santa Fe, Leyte for the restoration and reconstruction of the Municipal Hall Complex, destroyed by Typhoon "Haiyan or Yolanda", subject to existing laws, rules and regulations.
